Christine Bartholomew is a professor of law at University at Buffalo School of Law. She is a seven-time winner of the law school's only teaching award, the Faculty Award. In 2021, she was awarded the SUNY Chancellor's Award for Excellence in Teaching. She also received the 2019 Jacob B. Hyman Distinguished Professor Award and the 2020-2021 Mid-American Conference Institutional Award for Outstanding Faculty for Student Success.

She teaches evidence, antitrust, and civil procedure, and her scholarship focuses on the interplay of these topics, particularly in complex litigation. She is a member of the American Law Institute, an associate editor for the ABA Antitrust Law Journal, and her academic publications have appeared in many leading academic journals, including Duke Law Review, UCLA Law Review, Fordham Law Review, Virginia Law Review, and Vanderbilt Law Review. Her work has been cited by state and federal courts, as well as garnered media attention. She has been quoted in Slate, featured in The Conversation, quoted in major news outlines including USA Today, Reuters, and Mother Jones.

Braccia is the Director of the LL.M. in Trial Advocacy and a Practice Professor of Law at Temple University Beasley School of Law, where she brings particular expertise in courtroom technology, e-discovery issues, and trial skills. Prior to joining the full-time faculty, Professor Braccia taught Introduction to Trial Advocacy and an experiential course in criminal prosecution for several years as an adjunct in Temple's trial advocacy program. She has also served as a coach for Temple's National Trial Team.



Professor Braccia is an accomplished litigator, having served as an Assistant District Attorney in the Philadelphia District Attorney's office from 2006 to 2018 under D.A.s Abraham, Williams, Hodge, and Krasner. In addition to serving as a trial attorney in Major Trials and the Family Violence and Sexual Assault Unit, in 2012 Professor Braccia was appointed to a supervisory position in the District Attorney's Charging Unit, and in 2014 launched Philadelphia's Domestic Violence Diversion Program, assuming a caseload in excess of 200 dockets, monitoring participants' treatment progress, and reporting on program statistics to the DOJ's Office of Violence Against Women. In August 2017, she took on added responsibilities as Director of Information Technology for the DA's Office.

She presents frequently on gender bias in the courtroom, particularly as it impacts transgender and gender-diverse people and cisgender women. Braccia also teaches lawyers in Chile, Argentina, Ecuador, and Peru the fundamentals of American trial advocacy through Temple's Chilean pre-LL.M. program. She also teaches Evidence Law to Chinese legal professionals as part of the Temple-Tsinghua LL.M. degree program.

Professor Christopher Behan joined the faculty at Southern Illinois University's Simmons Law School in 2006 following nearly eleven years of distinguished service in the U.S. Army Judge Advocate General's Corps. During his military career, he served in a wide range of legal roles—including prosecutor, defense counsel, administrative and operational law attorney—and concluded his service as an Associate Professor of Criminal Law at the Judge Advocate General's School in Charlottesville, Virginia. At SIU, he has held multiple leadership positions, including Acting Dean (2017–2018) and Associate Dean for Academic Affairs (2014–2017).

Professor Behan earned his LL.M. in Military Law, specializing in Criminal Law, from the Judge Advocate General's School, where he was named to the Commandant's List. He received his J.D., magna cum laude, from BYU's J. Reuben Clark Law School, where he was a member of the Order of Barristers and the National Moot Court Team, and his B.A., magna cum laude, in English from BYU. His teaching and scholarship focus on military justice, evidence, national security law, and trial advocacy. Beyond SIU, he teaches advocacy programs for the National Institute of Trial Advocacy, Justice Advocacy Africa, and various legal organizations nationwide, and has served on the faculty of the National Judicial College in Reno, Nevada.

Professor Veronica J. Finkelstein is an accomplished litigator and educator who brings extensive federal practice experience to her teaching at the Wilmington University School of Law. Before entering academia full time, she served as an Assistant U.S. Attorney in the Department of Justice's Philadelphia office, where she became senior litigation counsel and received the Executive Office for U.S. Attorneys Director's Award for Superior Performance in 2014. During her tenure, she handled complex civil and criminal matters—including tort, employment, medical malpractice, and child exploitation cases—and led training programs for attorneys and paralegals. Earlier in her career, she clerked for the Honorable Jane Cutler Greenspan of the Pennsylvania Supreme Court and practiced construction litigation at Duane Morris LLP and Cohen Seglias Pallas Greenhall & Furman PC.

A nationally recognized teacher of advocacy, Professor Finkelstein has taught at the DOJ's National Advocacy Center and serves as a program director for the National Institute for Trial Advocacy. She previously taught at Drexel, Emory, and Rutgers Law Schools, earning Rutgers Law Adjunct Professor of the Year multiple times and Drexel's Carl "Tobey" Oxholm III Award for Outstanding Contribution to the Law Community. A graduate of Emory University School of Law with honors, she is co-author of *Ethical Lawyering: A Guide for the Well-Intentioned* and a member of the Order of Barristers.

Professor Gary S. Gildin joined the Dickinson Law faculty in 1979 after earning his J.D. from Stanford Law School and practicing civil litigation at Sonnenschein Carlin Nath & Rosenthal (now Dentons) in Chicago. He served as Dean of Dickinson Law from 2013 to 2019 and has held distinguished roles including U.S.—Canada Fulbright Visiting Chair in International Humanitarian Law at the University of Ottawa, Assistant Public Defender in Cumberland County, and law clerk to Judge Sylvia H. Rambo of the U.S. District Court for the Middle District of Pennsylvania.

A leading scholar and teacher, Professor Gildin has authored more than 40 publications and co-authored Trial Advocacy Basics (2nd ed.) for the National Institute for Trial Advocacy. He received the Roscoe Pound Foundation's Jacobson Award for Excellence in Teaching Trial Advocacy and has delivered over 60 lectures nationwide. His courses span trial advocacy, civil liberties, constitutional law, and evidence, among others. Beyond academia, he has argued pro bono cases before the U.S. Supreme Court and the Third Circuit, contributed to legal reform projects in Tajikistan, Armenia, and Ukraine, and regularly leads continuing legal education programs for attorneys. His career reflects a deep commitment to advancing advocacy, constitutional rights, and the global practice of law.

Professor Jules Epstein is the Edward D. Ohlbaum Professor of Law and Director of Advocacy Programs at Temple University Beasley School of Law. A leading authority on criminal law and evidence, he began his career with the Defender Association of Philadelphia and later became a partner at the renowned civil rights and criminal defense firm Kairys, Rudovsky, Messing, Feinberg & Lin LLP, where he remains of counsel. A graduate of the University of Pennsylvania Law School, he previously served as a professor and Director of the Taishoff Advocacy, Technology, and Public Service Institute at Widener Law.

Professor Epstein has authored numerous articles and books on criminal law, forensic evidence, and trial advocacy. His recent work focuses on capital cases, eyewitness reliability, and forensic science. He has taught death penalty law nationwide, continues to litigate capital appeals, and has served as an expert witness on eyewitness identification. Nationally, he was a member of the U.S. Department of Justice's National Commission on Forensic Science (2013–2017) and co-edited *Scientific Evidence Review* and *The Future of Evidence* for the ABA. He also teaches evidence and capital case law for the National Judicial College and serves on Pennsylvania commissions addressing wrongful convictions and jury instructions.

Michael Murray, University Research Professor and Spears Gilbert Professor of Law, has been teaching full time at the College of Law since his appointment in 2018. Previously, he was a Visiting Professor of Law in 2016-2017, when he taught Legal Writing, Professional Responsibility, and Advanced Legal Research and Writing at the College of Law.

Professor Murray graduated from Loyola College in Maryland and from Columbia Law School, where he was a Harlan Fiske Stone Scholar. He was a member of a national champion Jessup International Law Moot Court team at Columbia, and Notes Editor of the Columbia Journal of Transnational Law. After law school, he clerked for United States District Judge John F. Nangle of the Eastern District of Missouri, who was then the Chair of the Judicial Panel on Multidistrict Litigation. Murray also practiced commercial, intellectual property, and products liability litigation for seven years at Bryan Cave law firm in St. Louis. After leaving private practice, Professor Murray taught at the law schools of Saint Louis University, University of Illinois, Valparaiso University, University of Michigan, and University of Massachusetts, and internationally in Florence, Italy, and Cambridge, UK. Professor Murray currently has published twenty-seven books and forty law review articles on artificial Intelligence, blockchains, crypto currency and NFTs, advocacy, legal research and writing, rhetoric, copyright, art law, and other topics.

Professor Tony Ghiotto is the inaugural Director of the Kimball R. and Karen Gatsis Anderson Center for Advocacy and Professionalism at the University of Illinois College of Law, where he also serves as Director of Trial Advocacy and Teaching Assistant Professor of Law. He leads the College's nationally recognized trial and moot court programs and teaches foundational and advanced trial advocacy. His scholarship focuses on advocacy within criminal procedure and national security law, with publications in the Harvard National Security Journal, Buffalo Law Review, and North Dakota Law Review.

Before joining Illinois, Professor Ghiotto taught at Campbell University School of Law, where students twice named him "Professor of the Year." A veteran of the U.S. Air Force Judge Advocate General's Corps, he served nearly twelve years in roles including prosecutor, Staff Judge Advocate, and legal advisor to the Air Force's Judge Advocate General. He also contributed to the Defense Legal Policy Board's investigation into civilian casualty responses and deployed to Afghanistan in support of Operation Enduring Freedom. Still serving as a lieutenant colonel in the Air Force Reserve, Professor Ghiotto holds degrees from the University of Illinois, Emory University School of Law, and the Air Command and Staff College.
